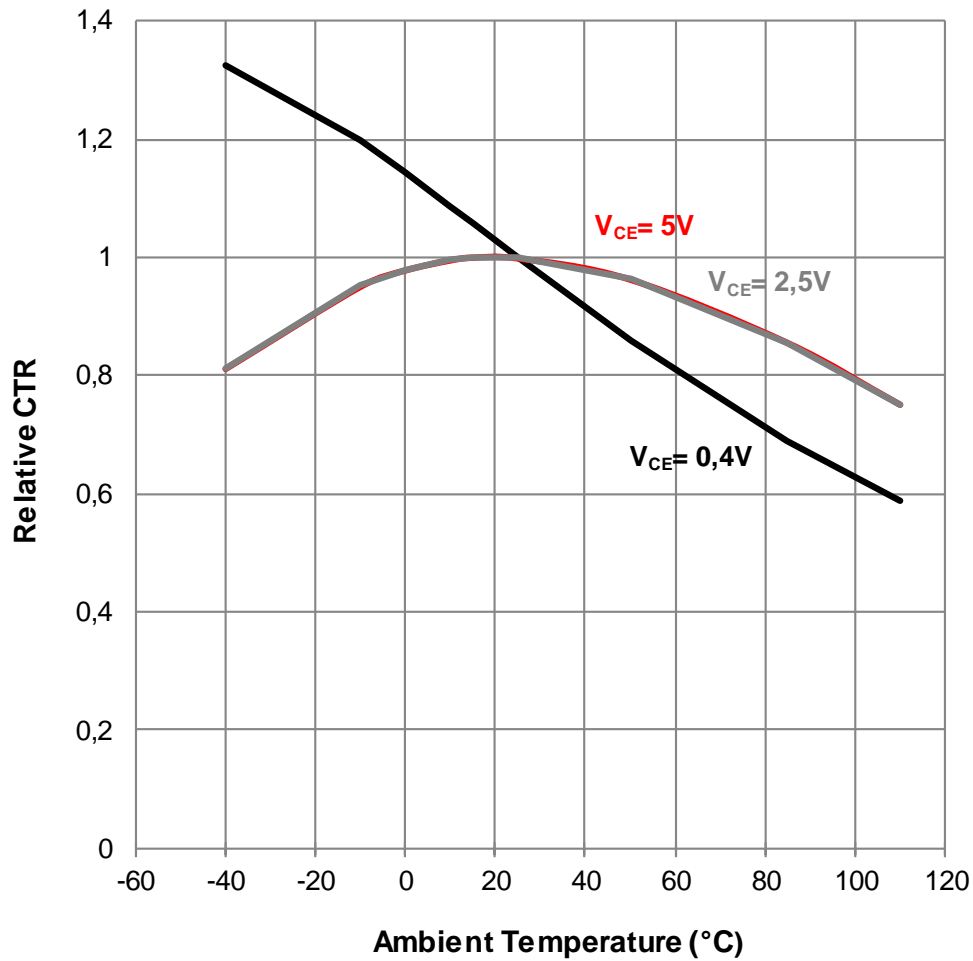

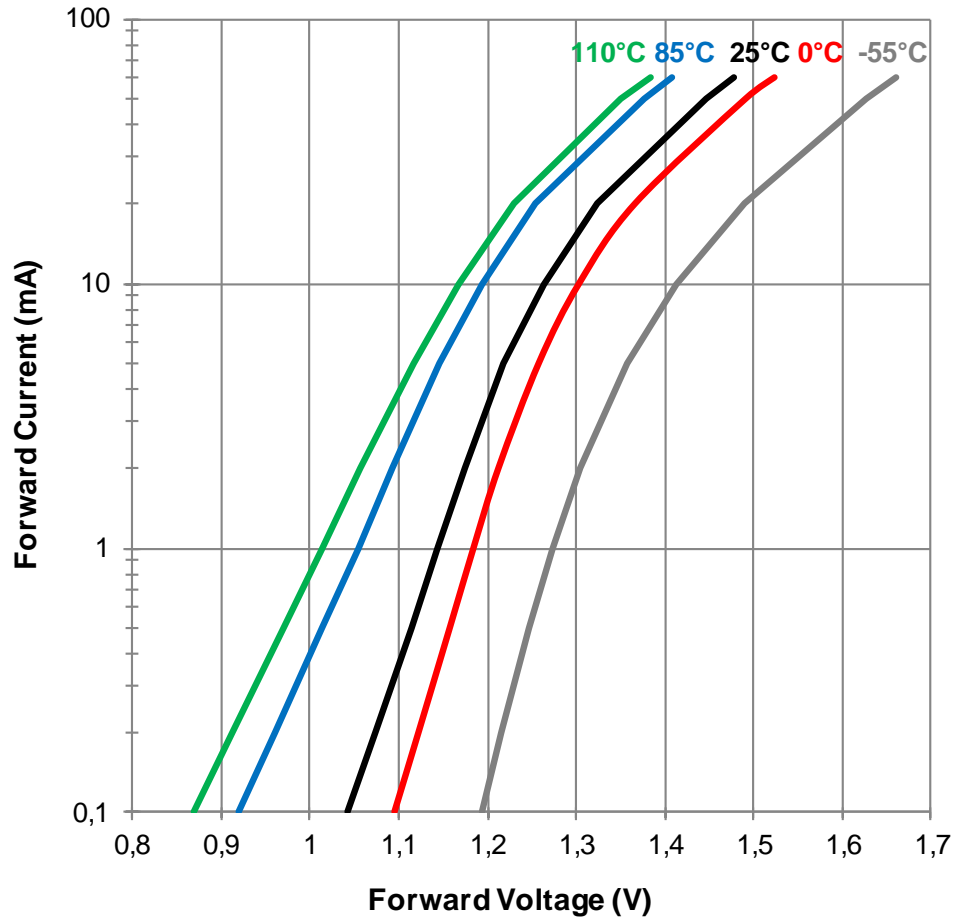
### Collector-Emitter Saturation Voltage vs. Ambient Temperature:



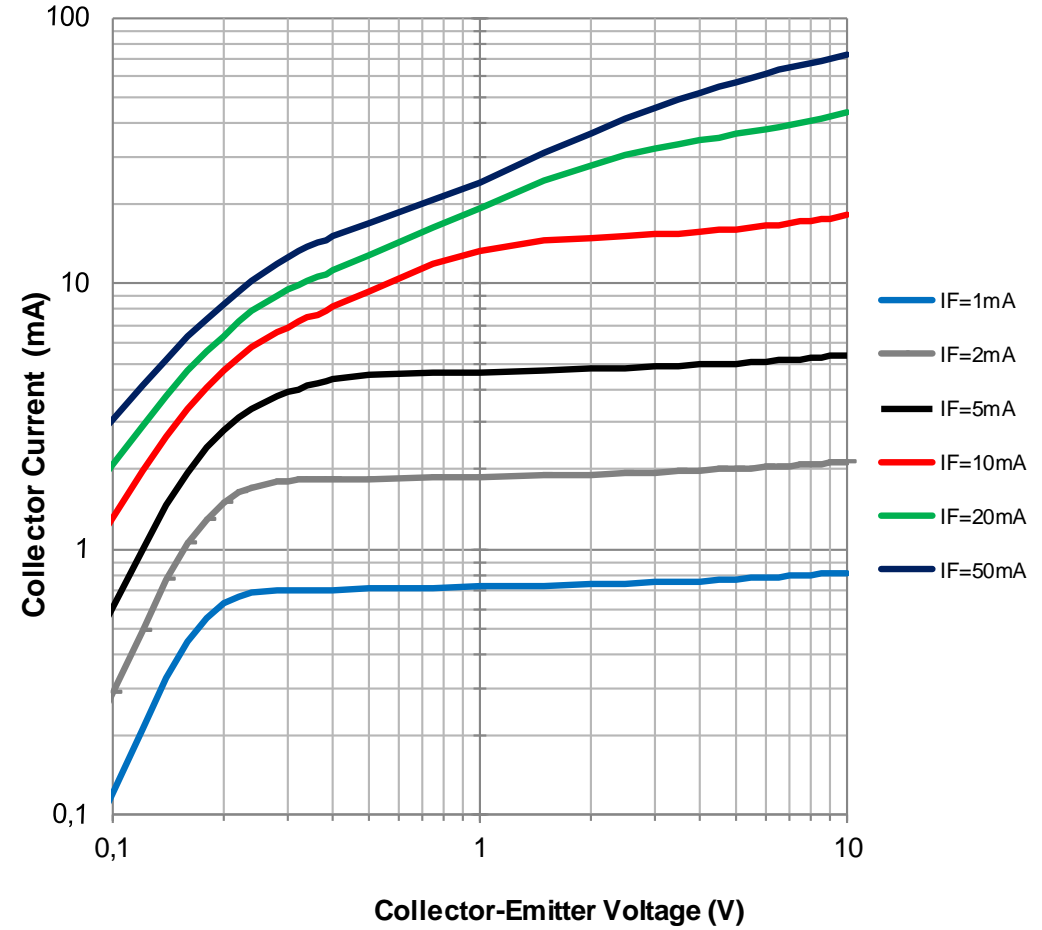

### Forward Current vs. Forward Voltage:



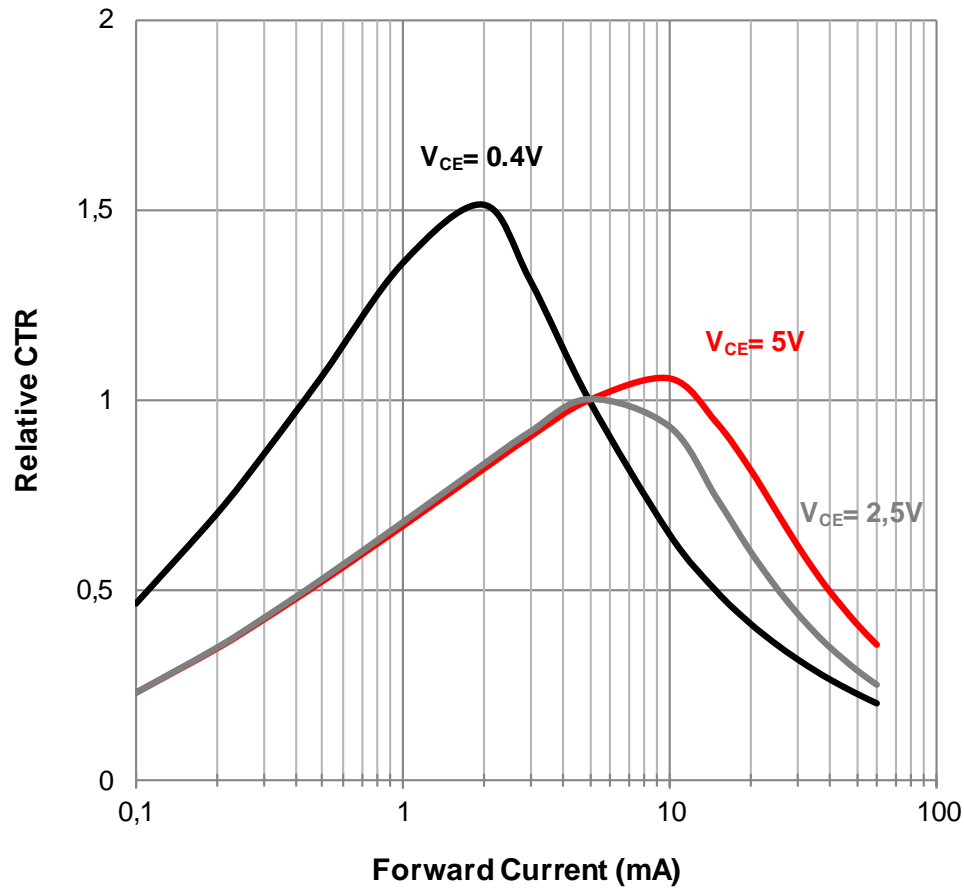
### Collector Current vs. Collector-Emitter Voltage:

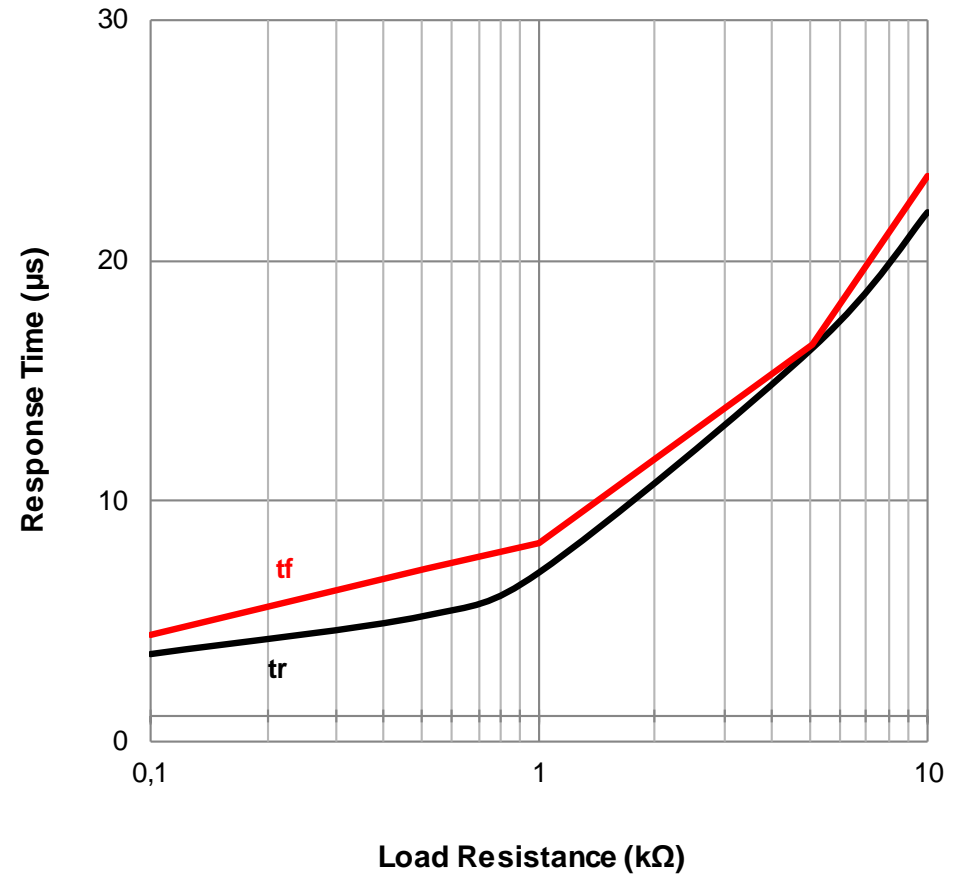

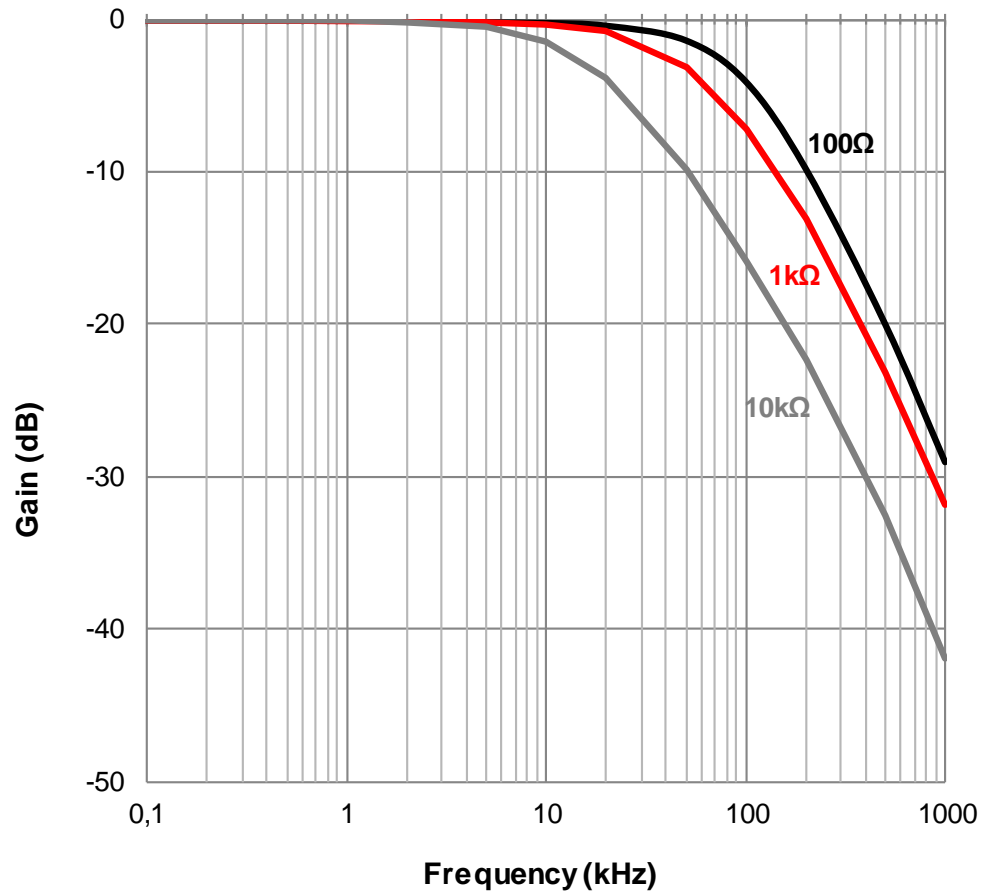
### Switching time vs. Load Resistance:

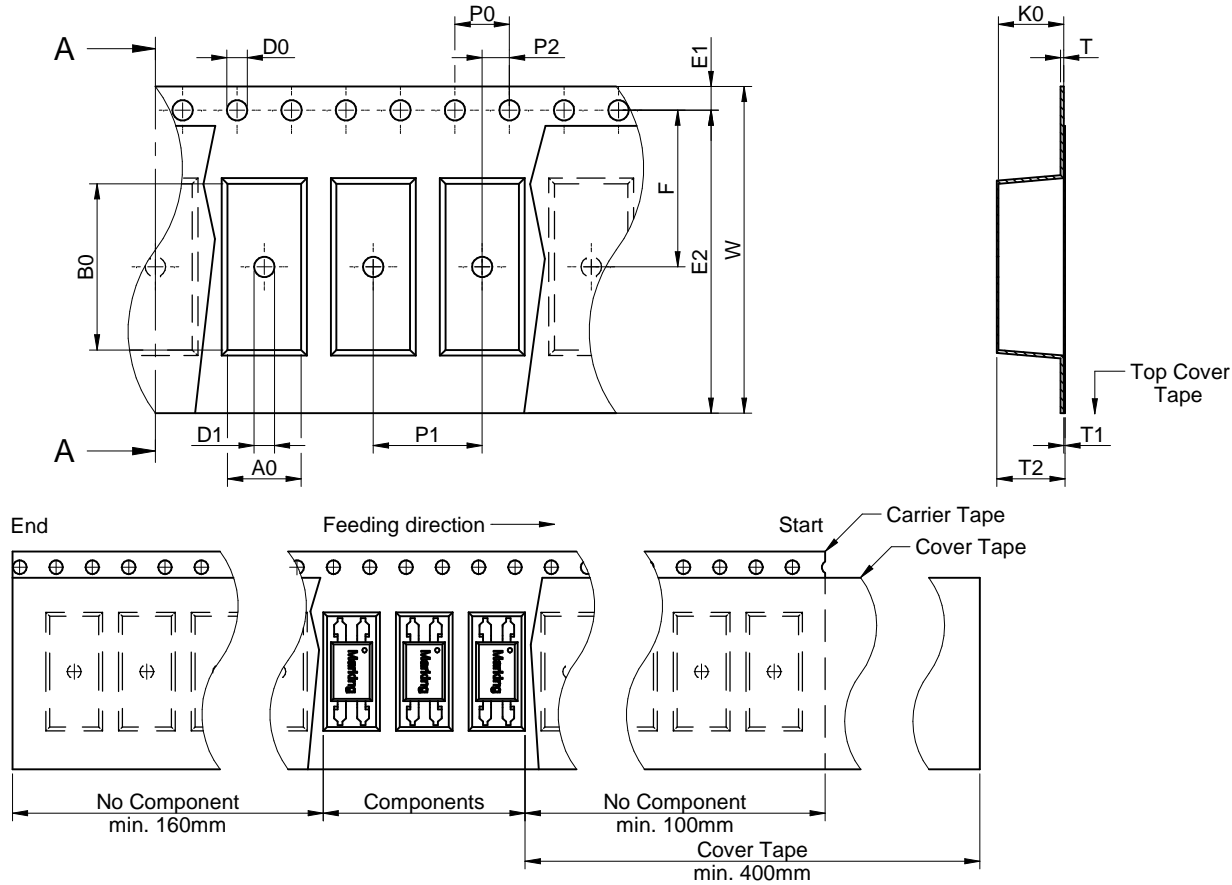

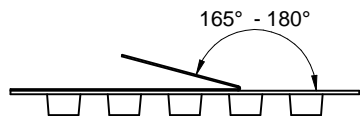

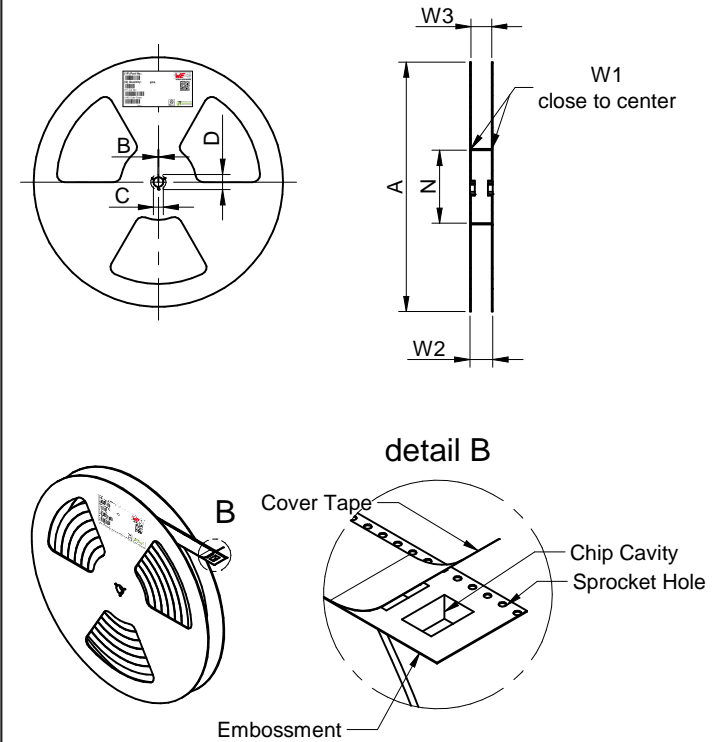

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.





As a standard reporting procedure of the Product Change Notification (PCN) according to the JEDEC-Standard inform about minor and major changes. In case of further queries regarding the PCN, the field sales engineer or the internal sales person in charge should be contacted. The basic responsibility of the customer as per Section 1 and 2 remains unaffected.

## 6. Product Life Cycle



