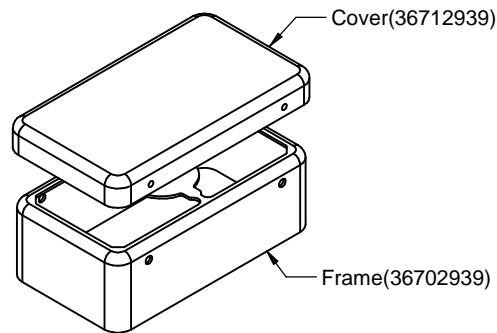


## Recommended Land Pattern: [mm]

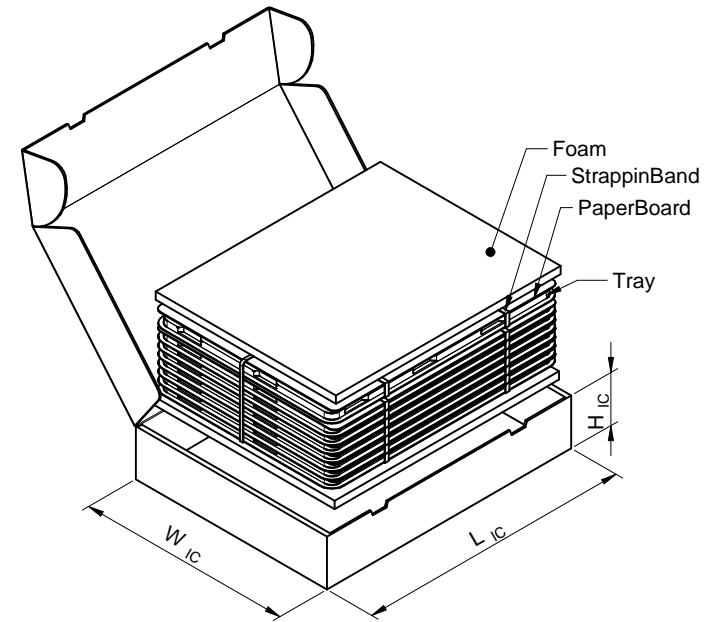



#### Storage Conditions:


