TYPICAL ELECTRICAL CHARACTERISTICS

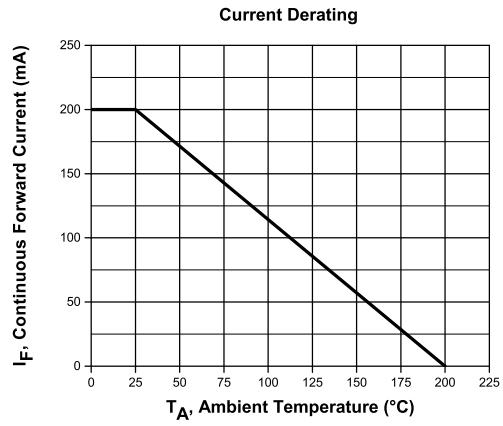
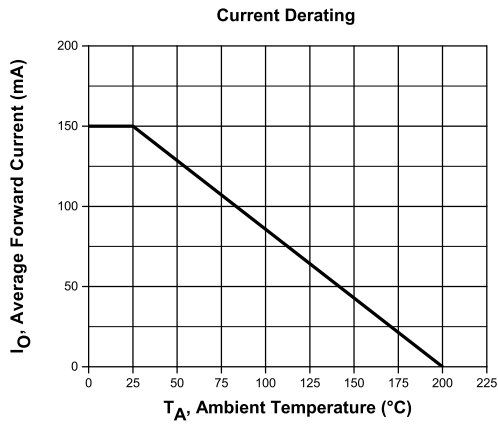
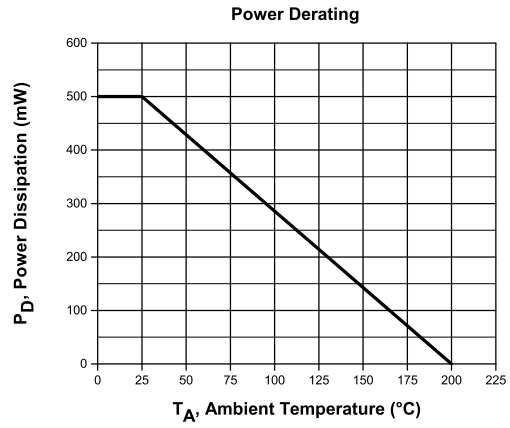
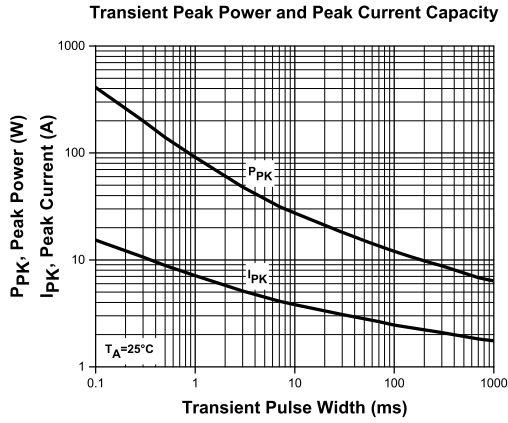
