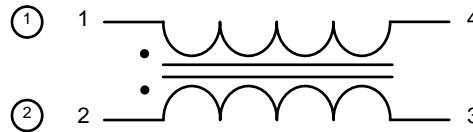

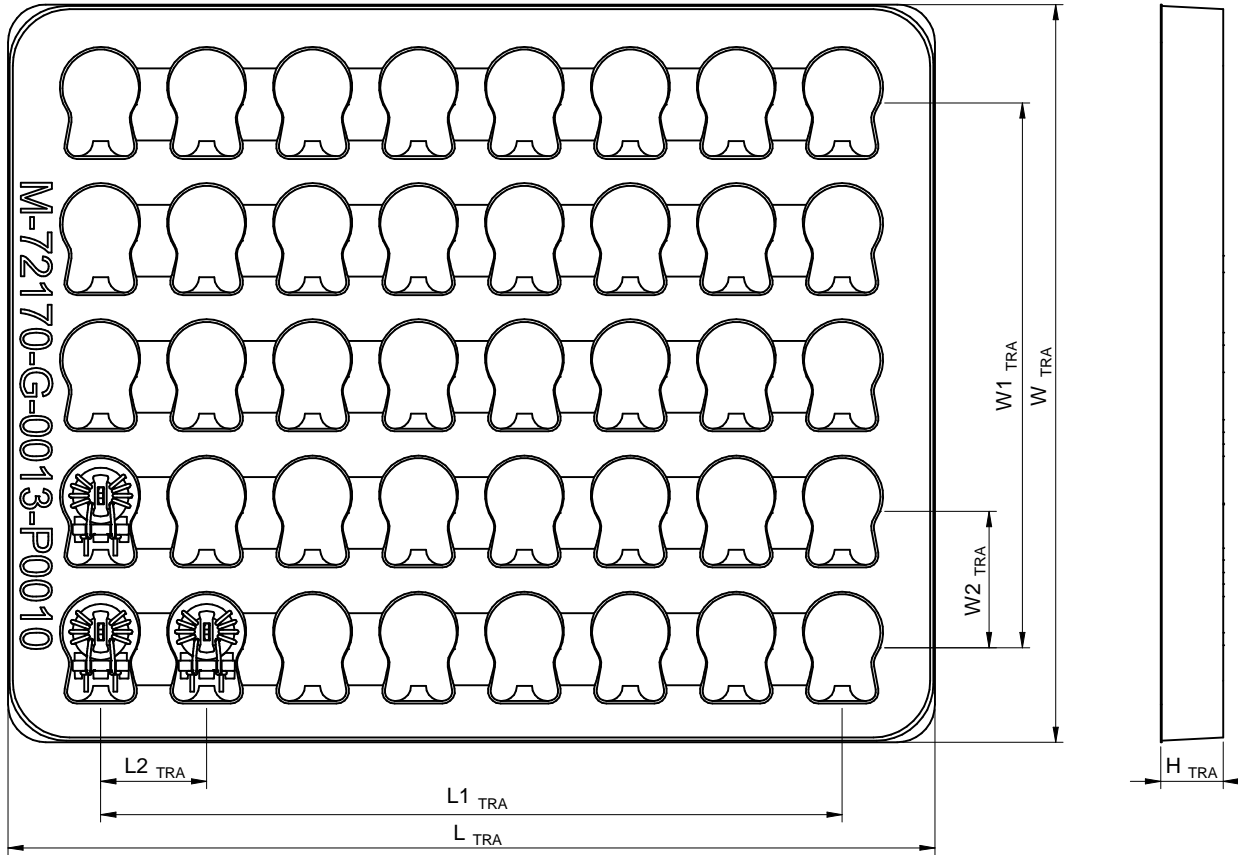
Differential Mode



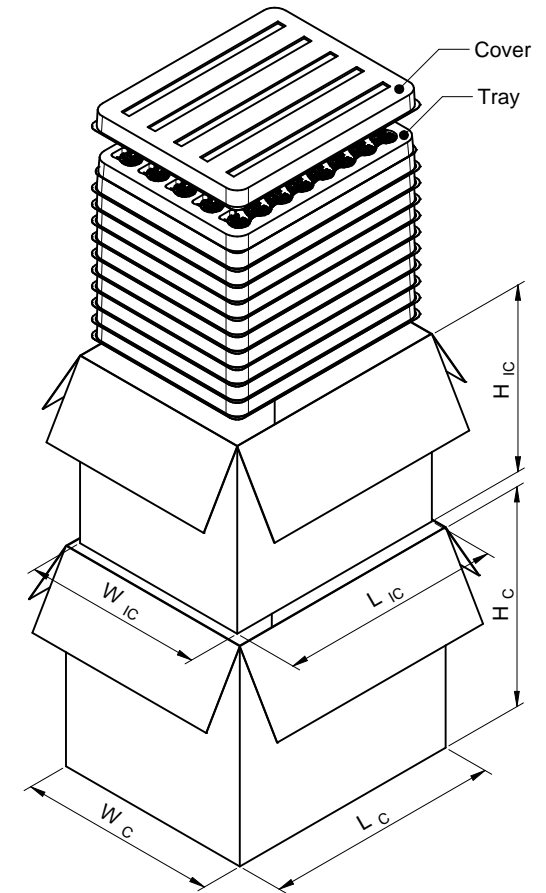



## Packaging:

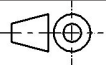
