Supersedes PCN P-20-018452 Dear Customer, as a result of our continuous improvement process we hereby inform you of several changes to our Micro D product, 1. Add an additional Micro D shell manufacturing location. The following Part Numbers will have shells manufactured at our current TE Connectivity facility located in Manheim PA and in our TE Connectivity facility located in Hermosillo, MX. 2. The addition of an internal undercut in the epoxy well of the Micro D shells used on the following part numbers. 3. The use of unetched wire for wire types 01 thru 04 and 09 thru 16. 4. Change from a stamped and formed pin contact design to a machined contact body with a twist pin contact design.

Reason for Changes:

Product improvement.Supersedes PCN P-20-018452 Dear Customer, we hereby inform you about the additional shell manufacturing location for added shell capacities. The additional location follows a strict procedure, which fully maintains quality, ability to supply and form-fit-function of the concerned products. The addition of the internal under cut will provide increase insert retention above and beyond the requirements of MIL-DTL-83513. Using Standard wire in MIL-DTL-83513 assemblies to support lead time reduction.
