#### Description for Product Change Notification

The following Product Change Notification was issued on other parts of this family in July of 2018. It has been discovered that more part numbers, the group associated with this notification, will also need the modification. In the event support is needed in obtain compatible parts, please contact your local sales representative for further assistance.

In consideration to a continuous improvement process of Phoenix Contact Push-in terminal blocks, there will be a change that effects the design of the covers mentioned below.

The change effects the snapping pin of the covers which are changed slightly to achieve an improved fitting. Therefore some pins are changed from round to rectangular. This change has no influence to the compatibility or the electrical performance of the products. Old and new shape are interchangeable, with the exception of the following...

1.It is not possible to mix the **old V/C** of D-PT 2.5-MT and D-PT 2.5-MTB with the **new V/C** of terminal block PT 2.5-MT/TG and PT 2.5-MTB in that case the covers need to be replaced

2.The mix of the new V/C of D-PT 2.5-MT and D-PT 2.5-MTB with the old V/C of terminal block PT 2.5-MT/TG and PT 2.5-MTB is possible


