The tape-on-reel packaging of unshielded M8 SMD items has been changed slightly to make the feed-in process for SMD components smoother. The dimensional changes are shown in the attached document. Both the pocket depth and also the geometry of the pocket have been optimized to ensure the stable fit of the components in the tape-on-reel packaging. The insulating bodies now sit higher in the tape-on-reel packaging, therefore optimizing the gripping or suction action. This change has no effect on the technical properties of the connectors. 
