




#### SPATIAL DISTRIBUTION



## **SUPER BRIGHT ORANGE**




#### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**




#### Notes

TAPE SPECIFICATIONS (units : mm)




#### REEL DIMENSION (units : mm)
