In an effort to ensure RoHS2 compliance and considering EU 2015/863, 3M is replacing the laminate film for the 3M[™] Twisted Pair Flat Cable, 3782 Series product line.

What is being changed?

- 1. The color of the laminate film will be changed from transparent to white.
- 2. New SKUs have been issued for each of the cable products offered.
