### Typical Insertion Loss:

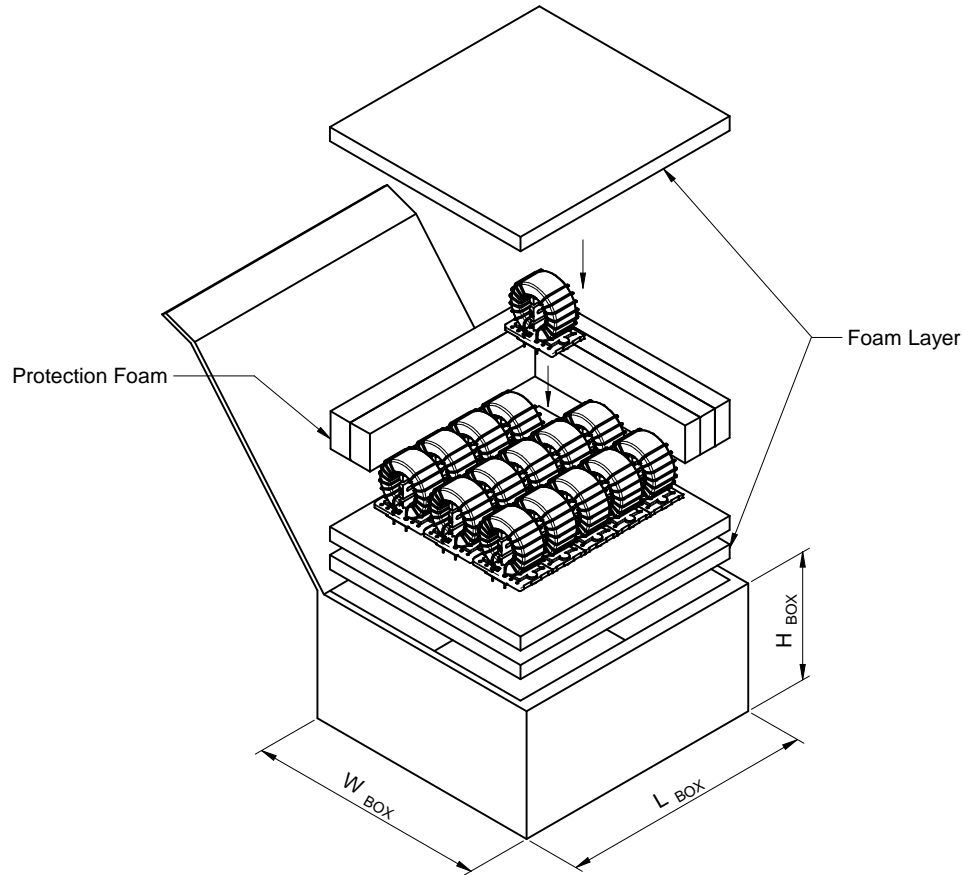

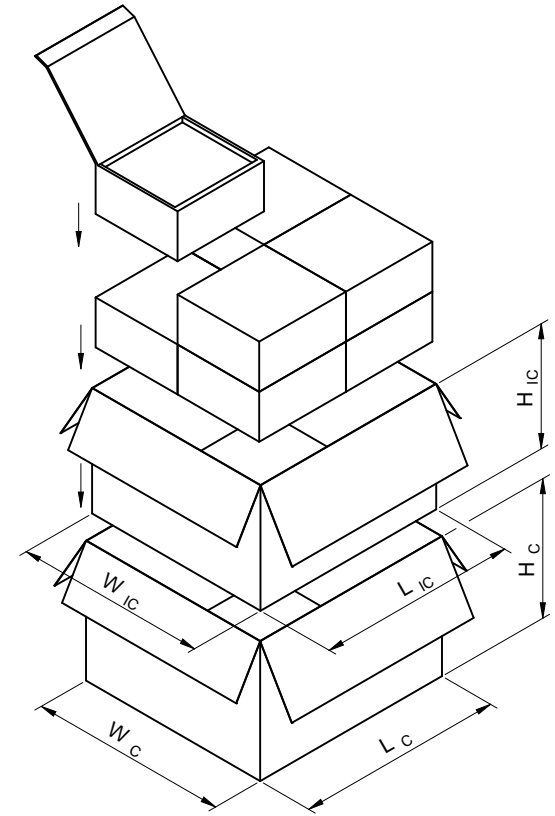

#### Soldering



## Storage Conditions:


