# **Maximum Peak Pulse Power Rating**




## **Peak Pulse Power and Current Derating**







# **Steady State Power Dissipation Derating**





# **Maximum Non-Repetitive Forward Surge Current**







# **Typical Junction Capacitance**




## **Storage Conditions**
