



# **Dimensional Analysis of Packaging**

- Current Packaging is 1 reel (20,000pcs) in Box 85-01-0015
  - Box Dimensions are 24 x 24 x 1.5"
  - Box has a center glue joint which is a weak spot for our terminal design (as shown on slide 1 before photo)
  - Small minor flaps at corners do no allow for compression strength when box is closed allowing corners to crush and potential for reels/product in box to be damaged during shipping and handling.
- New Packaging will be 4 reels (80,000pcs) in Box 85-02-0003
  - Box Dimensions are 24.75 x 24.25 x 4.75"
  - There is no center glue joint to cause a weak spot in the packaging
  - Corners have minor flaps that tuck well and provide the outer corners with additional compression strength during shipping and handling (as shown on slide 1 after photo)
