

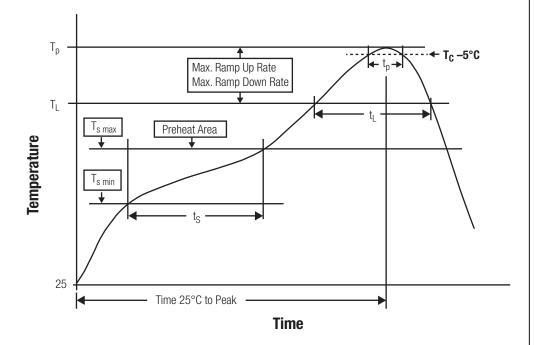

Soldering:
