Please also note that we have updated this drawing to remove the option for /225 adhesive coating from the largest size 202D196. The part description 202D196-25/225-0 is now no longer available. If adhesive is required for sealing on the 202D196-25-0, we recommend using system compatible adhesive such as S1125 two-part epoxy.
