#### Description for Product Discontinuation

Due to a discontinued component, the FL WLAN 510x series of WLAN devices has been discontinued. A form, fit and functional replacement is available. The FL WLAN 511x series is the replacement

The FL WLAN 5110 and FL WLAN 5111 are a drop in replacement for the discontinued product. They have the same form, function and are 100% backward compatible with the discontinued product. All approvals, including hazardous locations approvals, are also carried over to the new FL WLAN 511x series.

The main difference between the FL WLAN 510x series and the new FL WLAN 511x series is that the FL WLAN 511x series has 2 antenna ports instead of 3 antenna ports that the FL WLAN 510x series had.

Inventory of the older series is limited so please transition to the FL WLAN 511x series as soon as possible

FL WLAN 5111 is for use in the USA and Canada  
FL WLAN 5110 is for use **outside** the USA
