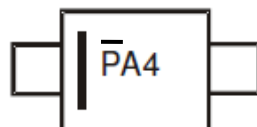

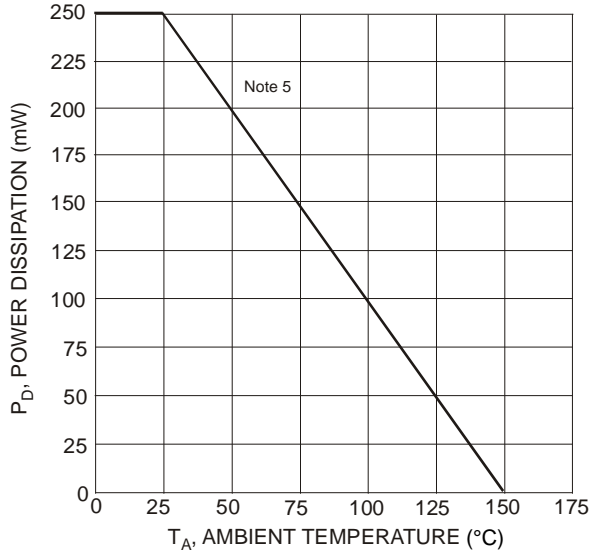


Figure 1. Power Derating Curve

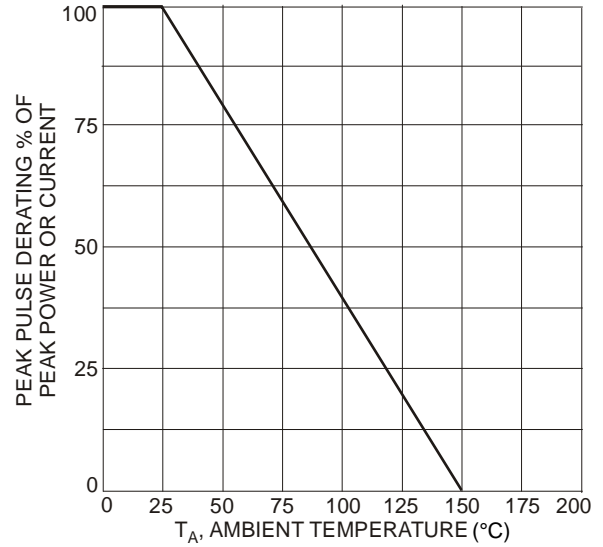


Figure 2. Pulse Derating Curve

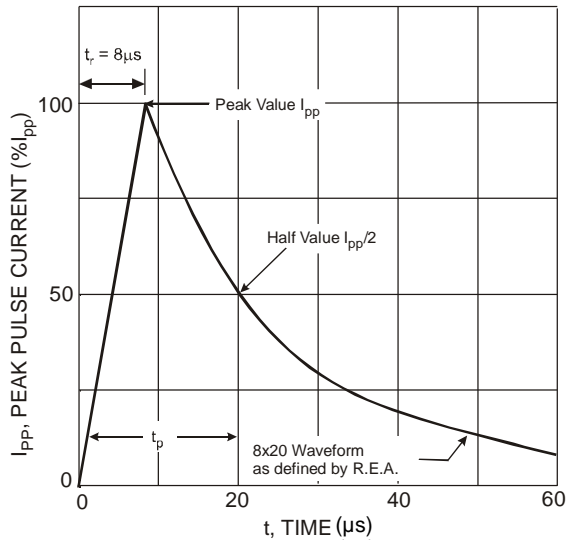


Figure 3. Pulse Waveform

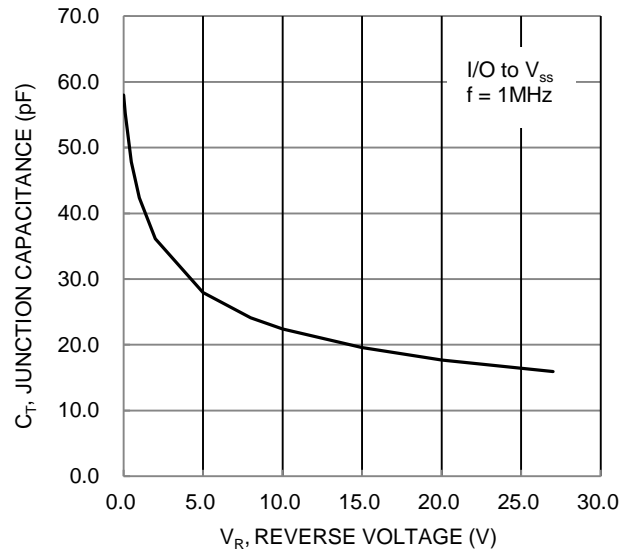


Figure 4. Typical Total Capacitance

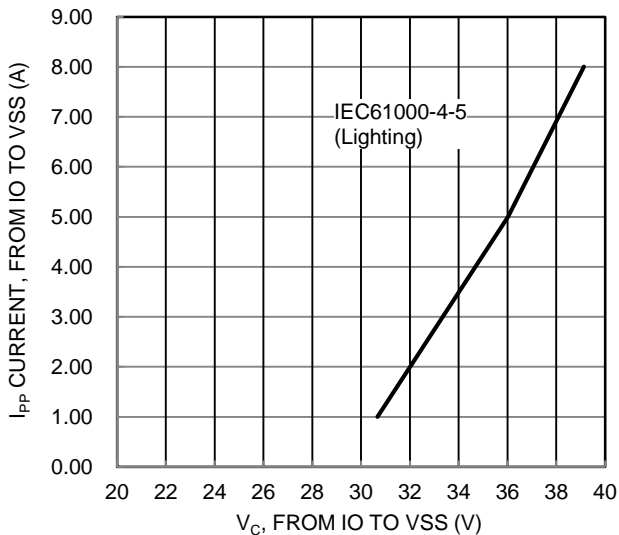


Figure 5. Clamping Voltage Characteristic

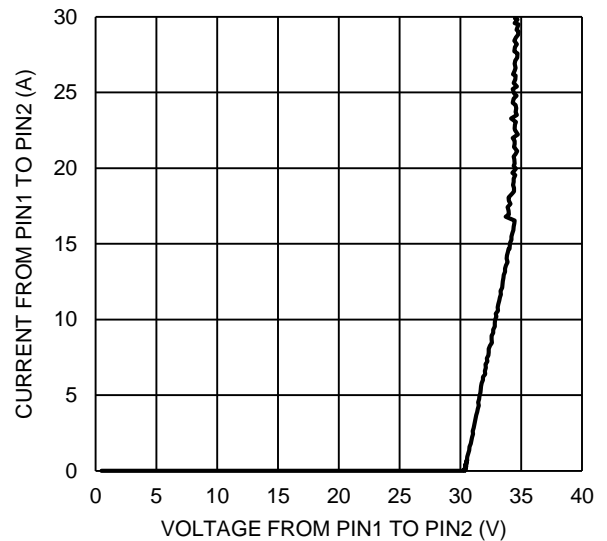


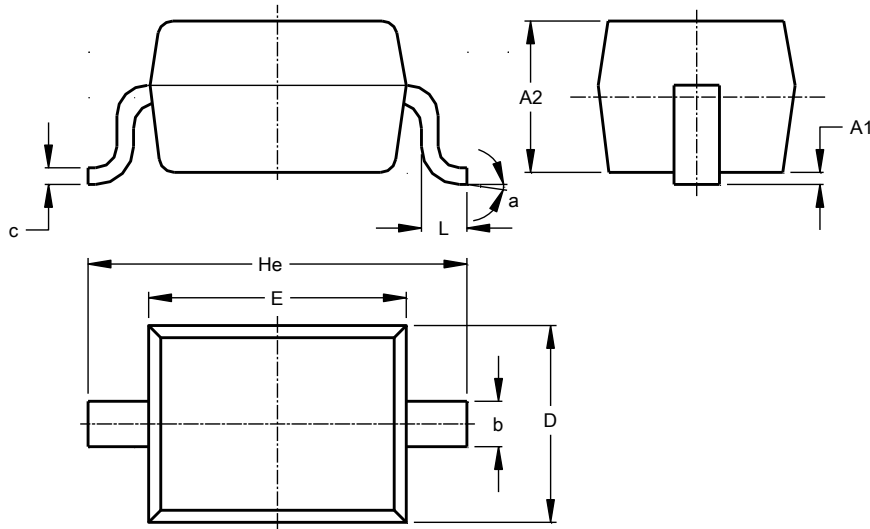
Figure 6. TLP Curve (t_p = 100ns)

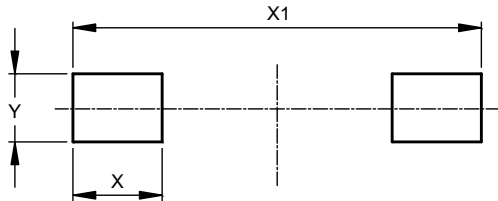
