

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- · All other soldering methods are at the customers' own risk.
- To improve the solderability of bottom termination components please refer to appnote ANPO36 on our homepage
- Make sure that you use the correct thickness of solder paste to avoid an insufficient soldering result. We recommend 100µm solder paste as a reference.

Cleaning and Washing:

Washing agents used during the production to clean the customer application may damage or change the characteristics of the wire

Potting:
