The TLV2371-DIE single supply operational amplifier provides rail-to-rail input and output capability. The TLV2371-DIE takes the minimum operating supply voltage down. The maximum recommended supply voltage is 16 V, which allows the devices to be operated from (± 8 V supplies down to ± 1.35 V) a variety of rechargeable cells.




