LEDIL will transition to new order codes, which make it easier to select and stock LEDIL product. The prefix (one, two, or three letter) indicates production location and packaging information. The 5 numbers that follow the prefix indicate drawing number. An underscore separates the prefix and drawing number from an alphanumeric description, which lists the product series, beam pattern and other descriptive information.

KEY BENEFITS

- Where two or more LEDs are approved for use in a customer design, end users can now specify one LEDiL order code for use.
- Authorized distributors will be able to stock fewer SKUs, thereby expanding their depth of LEDiL stock and ensuring quick delivery of product to our end users.
- Easier for receiving departments to verify receipts, as the product order codes now contain information indicating when an optics/holder combination is shipped assembled or as separate components, or with pre-installed mounting tape.
