NXP Semiconductors announces an adjustment to the import / export tariff codes, in-line with the Harmonized Tariff Schedule (HTS), for the devices associated with this notification. Some of the devices which had previously been classified as Transistors (HS 8541.21 or 8541.29), will now be classified as Integrated Circuit (8542.39), or Amplifier (8542.33). This change will have little to no impact on our customers, and is simply a correction of assigned tariff code.
