Description for Product Change Notification

Purpose/objective of the change

The battery component supplier and type need to be changed, as the battery type currently used in V/C:04 of the UPS and older is no longer available. The product designation, approvals, and product appearance remain unchanged. The change will be implemented manually and indicated with a corresponding message.

Detailed description of the change

The Panasonic type LC-R121R3PG battery blocks currently used will be replaced with BB battery type BP1.2-12FR. The product markings, approvals, and the product appearance will remain unchanged. The manual will be updated with a note and technical specifications. Mechanics, hardware, and firmware will be adapted to this change. The statement with a battery capacity of 1.3 Ah will remain.

Due to the change of the battery type and slight electrical characteristics, the replacement batteries for V/C:05 are not backwards compatible with V/C:04 or earlier. The replacement battery for V/C:05 BB battery type BP1.2-12FR may only be used on V/C:05 or newer variants. This incompatibility requires the entire unit to be replaced with item 2320254-05 once the previously installed products indicate that a battery change is required.
