Document Clarification. In an effort to standardize raw material on a global basis, TE Connectivity has completed a review of our current material standards for Brass connectors. This review has resulted in our decision to reduce the number of regional alloys and align at the global level by standardizing on C27400 alloy. Material certification will be supplied, by part number, upon request. Test data shows no reduction in performance and is available upon request.
