Packaging quantity change on floating washer

Description of Changes

This product change notification(PCN) is to inform about change in TE owned packaging. In order to assure standardized and uniform packaging for each basic product part number and to improve sustainability we will increase the standard quantity from 8pcs/bag to 100pcs/bag and therefore shipping quantity from 1440pcs to 1600pcs/box. Minimum order quantity(MOQ) will be changed from 1440pcs to 1600pcs. Dimensions of shipping box will be changed from 300*180*170mm to 270*230*125mm. TE change process follows a strict procedure, which fully maintains quality and ability to supply. Internal release process is is ensured by TE. In first shipments after change introduction a mixed shipment might occur(floating washer with old and new quantities). The change has no impact to form fit function. No PPAP will be submitted for this informational PCN. Other attachments:
