Mounting screws and washers are stainless steel. Clarify tin plating finish may discolor (note 1). Added operating temperature range (note 3) and added rubber boot length, D dimension. IMPORTANT: This is documentation clarification only and does not affect part fit or function. All product in stock and field are not affected and can be used interchangeably in the field.
