TE business unit operations are simplifying our manufacturing footprint to provide a more continuous efficient supply of product. As a result, the parts noted in this document will be relocating products from outvendor to TE QingDao, China under the same certified quality management system. Note: Due to limited capacity and delivery urgency, we are waiving Agreement 91 wait-period for this transfer.

Reason for Changes:

The new manufacturing location operates under a certified quality management system in accordance with standard automotive requirements.
