#### **Last Time Buy Conditions:**

- Last Time Buy orders must be accepted by 3M on or before **March 31, 2016**, and must be scheduled for shipment on or before **April 30, 2016**. Each Last Time Buy order must meet the Minimum Order Quantity value of \$1,500 USD and may not be revised or canceled and must state this on the Purchase Order.
- If an Affected Product or one of its components or raw materials is in short supply, 3M may allocate the available supply among its customers as 3M considers equitable or offer to sell an equivalent performing alternative material.
- Last Time Buy order deliveries will be based on 3M's component and raw material availability.
- The End of Life Warranty Statement below applies to all Affected Product purchases.

## **End of Life Warranty Statement**

The Affected Products will reach their End of Life on March 31, 2016. On or before April 30, 2016, 3M may cease to have replacement product available, so 3M, as it sole obligation and your exclusive remedy, may only be able to issue customer credit for an Affected Product that fails to meet 3M's warranty. Customers should contact 3M's Customer Service to: (a) report any Affected Product not meeting 3M's warranty; and (b) get a Return Material Authorization ("RMA") before returning any such Affected Product. All other terms and conditions of 3M's warranty remain unchanged.
