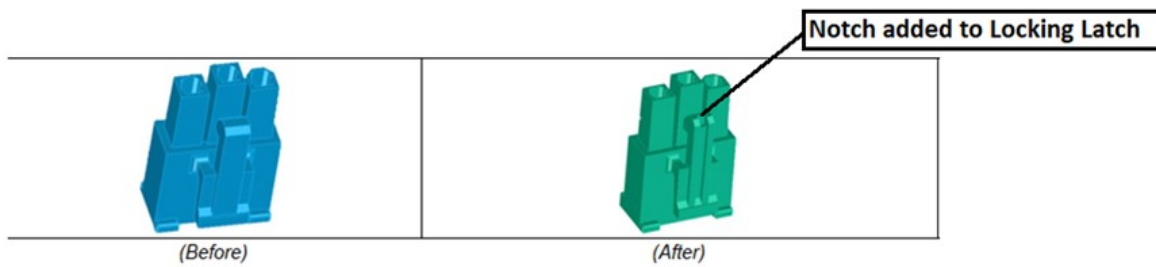

## Overview

- To ensure business continuity, Molex Lincoln Nebraska is needing to replace tooling for the Mini-Fit Jr 3ckt receptacle due to the age of the current tool.
  - New tooling will be changed to improve mold flow during part production
  - Product from the New tooling from Lincoln Nebraska will have a notch added to the Locking Latch
    - Notch in Locking Latch is to improve mold flow and reduce short fill of product
    - Product made from other locations will not have this notch
- Change will impact Appearance of the part at Locking Latch location
- There will be NO change to the Fit, Form or Function of the parts
