Description and Purpose:

Certain Ambient Light Sensor devices are no longer meeting ON Semiconductor's business requirements, which has resulted in our decision to discontinue these products. Products affected in this portfolio are listed below.

ON Semiconductor has decided to exit the business of certain ambient light sensor devices and we have licensed these products to our former subcontractor for these devices, Pixon Technologies. The licensing agreement between ON Semiconductor and Pixon Technologies prohibits ON Semiconductor from selling the devices listed in this Product Discontinuance Notice beyond June 28, 2019. We therefore wish to notify you promptly of our intent to exit this portion of our overall portfolio so that you may plan appropriately and effectively for the transition to Pixon Technologies as your new supplier for the impacted devices.
