RE: HCS Bypass Relay-Notice of Potential Safe Failure Mode

Hubbell Control Solutions ("HCS") is voluntarily notifying distributors and end-users identified as receiving HCS's Bypass Relay Catalog No. UL924BRUNV (the "Device") manufactured by a third-party supplier LVS, Inc. ("Supplier") that may be defective. The lot of impacted Devices is limited and HLI has identified all affected shipments. The shipment(s) in question are listed on the second page of this letter. The Device, pictured below, channels emergency power in a circuit and can be identified by its rectangular shape and "LVS" marking with Model EPC-A-1.

The Supplier has found that some Devices were manufactured in a way that, when connected to a 277V normal utility circuit, may overheat causing a subsequent safe failure mode. The Supplier has since corrected its manufacturing inconsistencies and is supplying HCS with new Devices. We are working to identify the end users that received this Device and to facilitate remediation. We are asking for your assistance in that effort.

The following actions by your company are needed immediately:

Your company's purchase order(s) are listed on the accompanying page. Any issues are limited to those specific purchases. We need your immediate help in identifying the end-users to whom your company distributed the Devices. We are asking that you immediately forward the attached notification "Important End-User Product Advisory" to those end-users and to email a list of affected end users to HubbellWarranty@lvscontrols.com. Once identified, the Supplier will work directly with end-users to resolve the issue.
