Thailand was hit by a devastating flood that impacted the production of Atmel's assembly subcontractor Chinteik Electronic Industries Co., Ltd (CEI). Due to the continued serious flooding the production at the CEI facilities is disrupted for an indefinite period of time.							
This uncertainty has led Atmel to stop the manufacturing in the current assembly location and to transfer the assembly activities of the Dual Triple Driver IC ATA6829-T3QY to AMKOR, Philippines. This transfer was announced in an ACN dated November 21, 2011. The package qualification is completed now.
