Resin material Change to TE Component

Description of Changes

Alternate resin to improve the performance and robustness of TE sub-component 2203005. TE sub-assembly part number(s) affected are 2287906 and 2203452. Validation testing to the latest SAE/USCAR-2 USCAR-17 and HES D3217-15 have been completed. No change to customer print since sub-component of assembly has not changed dimensionally.

Reason for Changes:

Product improvement. Micro-cracks appear on the existing nose cone material during press fit post assembly. New material was developed to provide improved performance to resolve this issues. Material change does not affect dimensional fit, form, or function.
