Description for Product Change Notification

The hardware will be revised to safeguard availability of the ILC 1x1-series controller family. As a part of this revision, the CPU clocking frequency will be increased to 96 MHz for devices from hardware version 03. Firmware version 4.70 has been issued to support the new hardware. This firmware can only be installed and used in devices from hardware version 03. PC Worx projects that were created for earlier firmware versions are compatible with firmware version 4.7. As a part of the hardware revision, the internal battery for buffering the real-time clock has been replaced with a capacitor. Therefore, the system variable RTC_BATTERY_LOW will no longer be supported. We will implement this change at very short notice to safeguard availability of the ILC 1x1-series controller family.

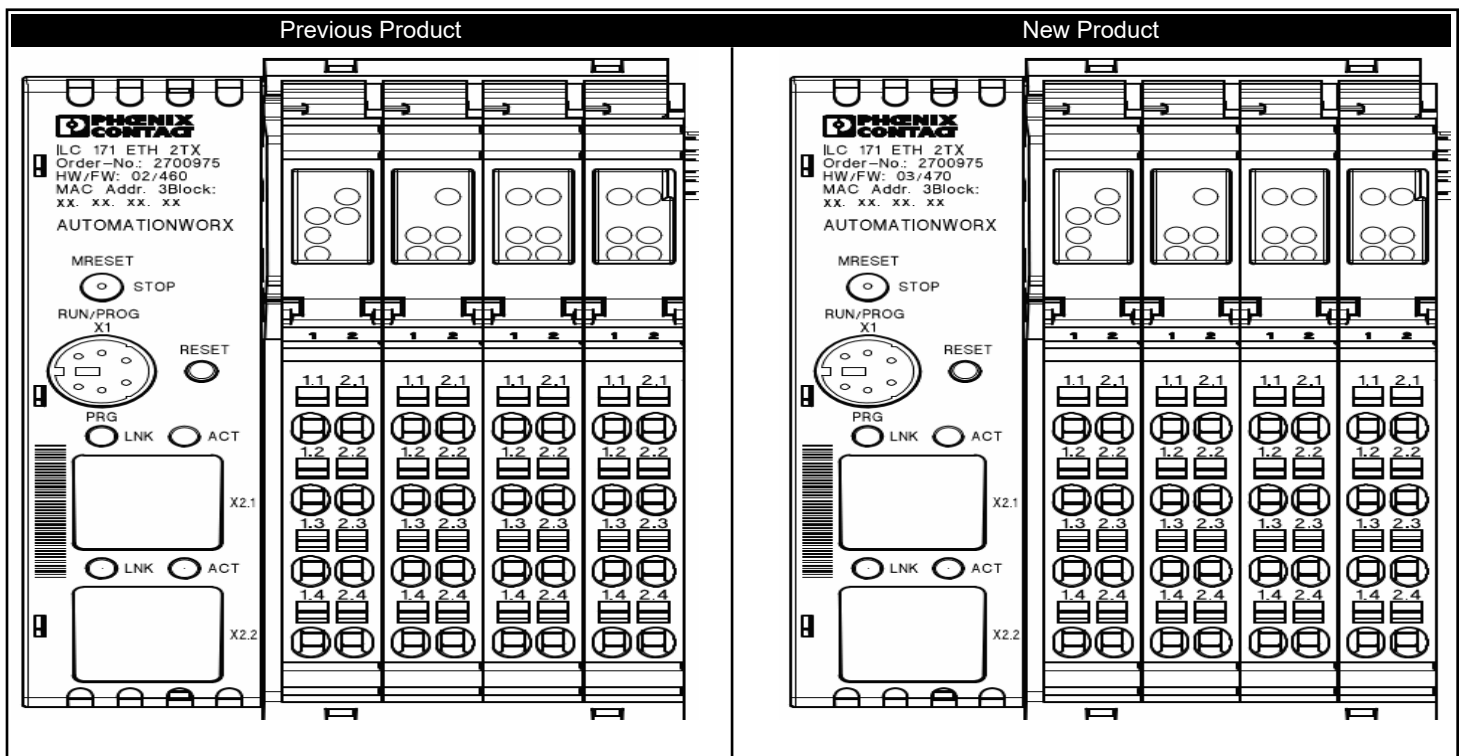


