





Figure 2. Relative variation of thermal impedance junction to case versus pulse duration $Z_{\text{th(j-c)}}/R_{\text{th(j-c)}}$ 1.0 0.9 0.8 0.7 0.6 0.5 0.4 0.3 0.2 t_P(s) 0.1 0.0 1.E-03 1.E-04 1.E-02 1.E-01 1.E+00




Figure 6. Normalized avalanche power derating versus pulse duration (T_j = 125 °C)






Figure 8. PSMC (TO-277A) package outline


