### Change Description

Altera will discontinue factory shipments of the MAX<sup>®</sup> 10 FPGA Evaluation Kit ordering code in Table 1.

### Reason for Change

The FPGA featured on this Evaluation Kit has transitioned from 'Engineering Sample' (ES) to 'Production'. The evaluation kit will now be manufactured using the 10M08SAE144C7G. The production version of this kit is an exact form, fit, and function equivalent to the previous kit. It is now available for bookings and shipments (with standard 4-8 weeks lead-time). Distributors with inventory of the ES kits will continue to ship until depletion then convert to the replacement part number.
