### Typical Inductance vs. Frequency Characteristics:



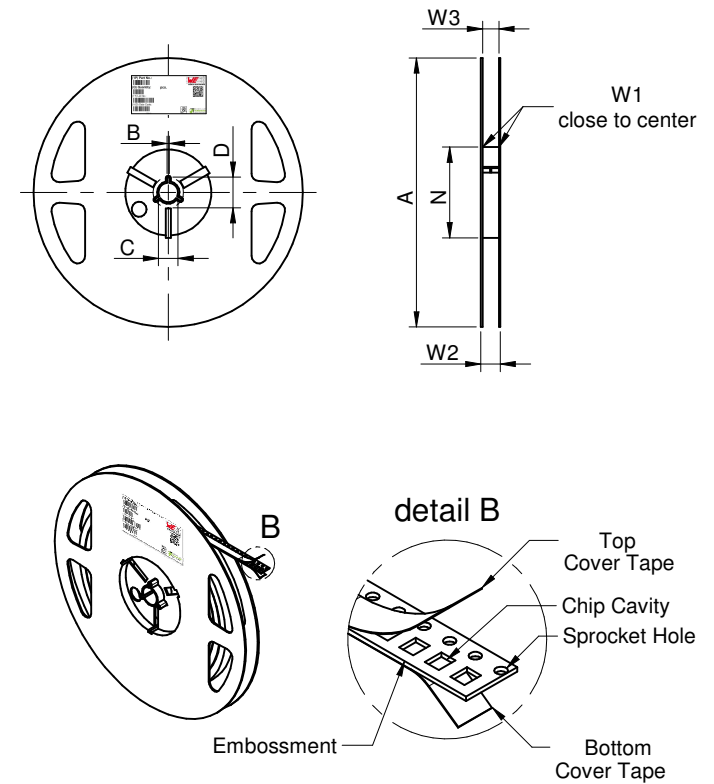

#### Soldering:



## Storage Conditions:


