The following Phoenix Contact products have been modified. Existing specifications will be met or exceeded. Please review and acknowledge this document and inform your personnel as needed.

Description of Change:

Effective immediately, 2866378 (QUINT-PS-24DC/24DC/10) is no longer approved or labeled with the CID2 approval information. This change occurred in production during week 29 of 2012 (week of July 16th). Due to the flow of inventory in our global network, we did not receive this inventory until mid-2013.

All current production of 2866378 which is Rev 04, does not have the CID2 labeling nor will any future revisions. Because of this change, the replacement for this DC/DC converter is the newer QUINT IQ device 2320092 (QUINT-PS/24DC/24DC/10) which IS CID2 approved and labeled.

This notice is only of concern if a customer is using the product in a CID2 classified location. If the production date on 2866378 is BEFORE 12/29, there is no concern as those products maintain their CID2 status.


