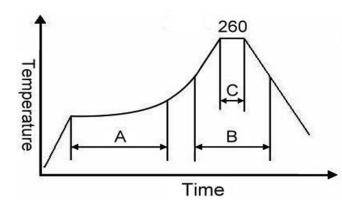

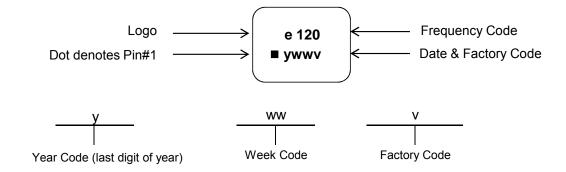

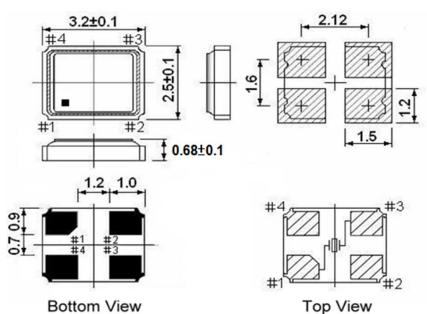

** Recommended - Pin 1 & 3 : CRYSTAL Pin 2 & 4 : GND

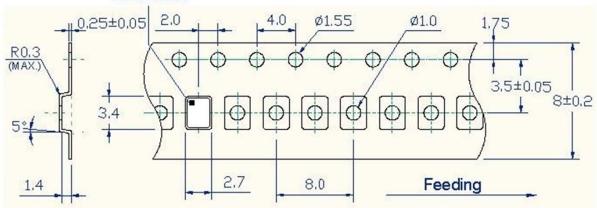

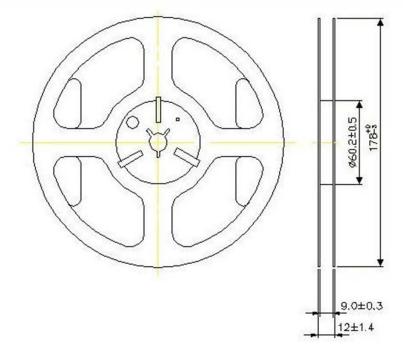
