

DESCRIPTION

As part of the SurfLight[™] portfolio, the VSMY98545ADS is an infrared, 850 nm emitting diode based on surface emitter technology with high radiant power and high speed, molded in low thermal resistance SMD package with lens. A 42 mil chip provides outstanding radiant intensity and allows DC operation of the device up to 1 A. Superior ESD characteristics are ensured by an integrated Zener diode.





Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Forward Current Limit vs. Ambient Temperature




Fig. 3 - Forward Current vs. Forward Voltage




Fig. 4 - Relative Radiant Intensity vs. Forward Current






Fig. 5 - Relative Radiant Intensity vs. Wavelength









Fig. 6 - Relative Radiant Intensity vs. Angular Displacement



PACKAGE DIMENSIONS in millimeters









DRYPACK

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

FLOOR LIFE

Floor life (time between soldering and removing from MBB) must not exceed the time indicated on MBB label:

Floor life: 168 h

Conditions: $T_{amb} < 30\ ^\circ C,\ RH < 60\ \%$

Moisture sensitivity level 3, according to J-STD-020B

DRYING

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or label. Devices taped on reel dry using recommended conditions 192 h at 40 °C (+ 5 °C), RH < 5 %.
