sectional drawing A-A

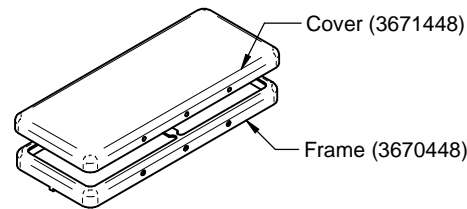


## Recommended Land Pattern: [mm]



#### Storage Conditions:

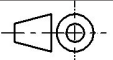
