Details of this change

Location

The wire diameter for product PESD24VS5UD will be changed from $50\mu m$ to $22.5\mu m$. The wire material Au remains unchanged. The wire bond process with $22.5\mu m$ Au is already released and in production at the assembly site Nexperia ATSN. No change in other package related parameters like die attach, wire routing, mold compound. Die design and active area remain unchanged.
