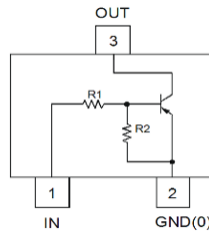

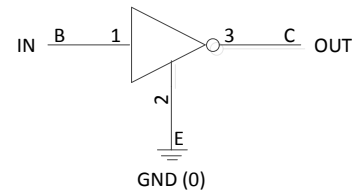

Equivalent Inverter Circuit

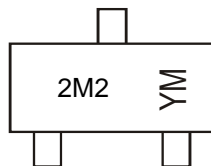

**Transient Thermal Impedance**



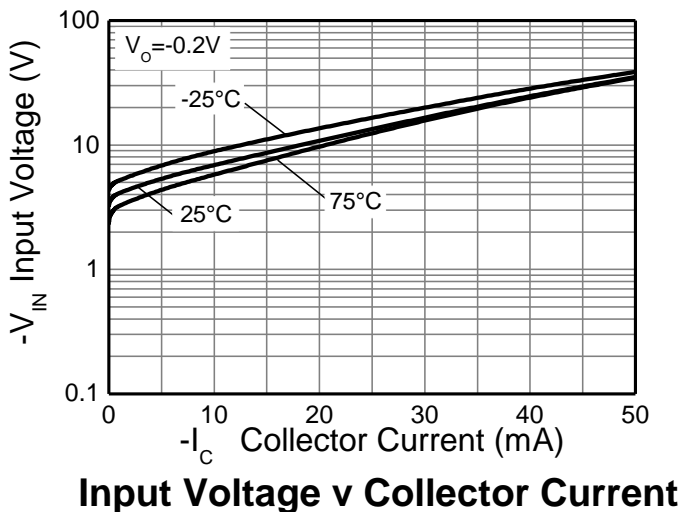
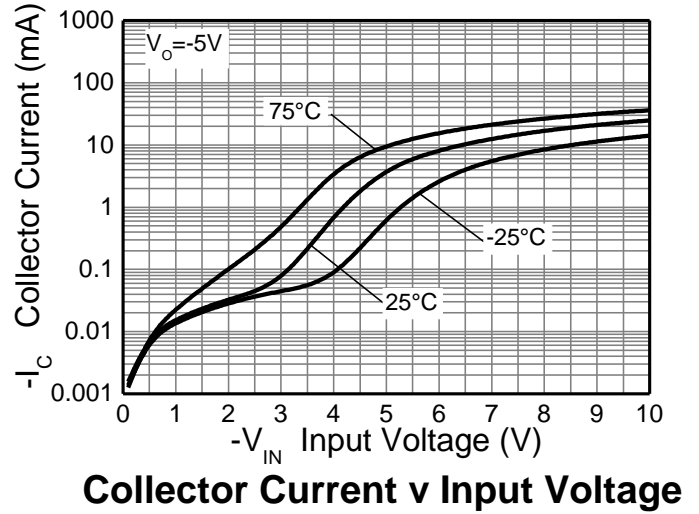
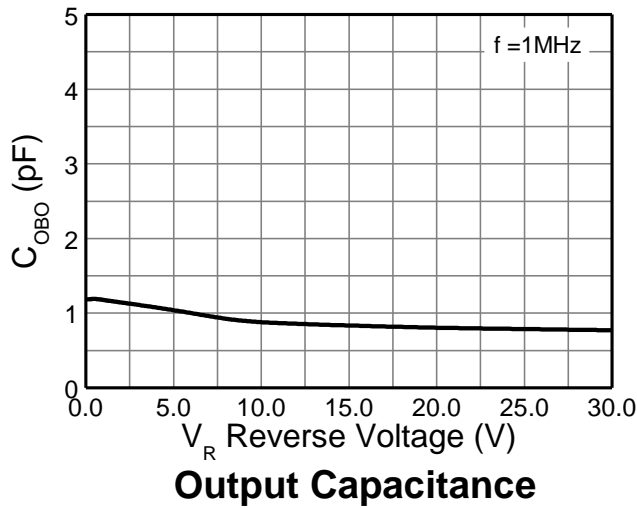
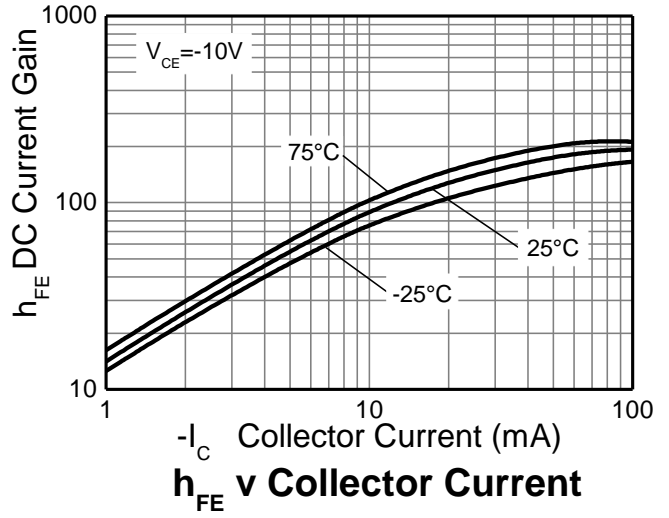
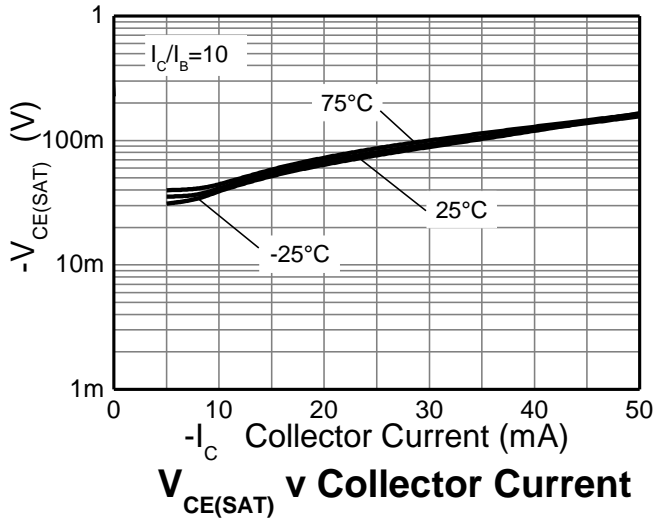
