The CPC40055ST recommended replacement device has identical output specifications and package dimensions as the CPC44055ST. The difference is the input control signal to operate the device, the CPC40055ST is current controlled (5mA Control Current) as compared to the CPC44055ST which is voltage controlled (9 to 16V Input Control Voltage).
