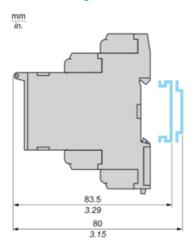

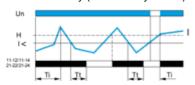

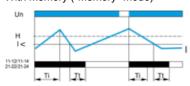

Without memory ("No Memory" mode)

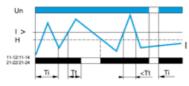


With memory ("Memory" mode)

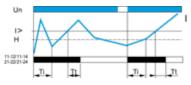
