




#### **Relative CTR vs. Ambient Temperature:**






#### **Collector-Emitter Saturation Voltage vs. Ambient Temperature:**




### **Forward Current vs. Forward Voltage:**





#### **Collector Current vs. Collector-Emitter Voltage, saturated**





## Absolute CTR vs. Forward Current ( at $V_{CE}=5 V$ )




## Relative CTR vs. Forward Current ( at $V_{CF}=5 V$ )





#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk
- The soldering pad pattern shown above is a general recommendation for the easy assembly of optoelectronic components. If a high
  degree of precision is required for the selected application (i.e. high density assembly), the customer must ensure that the soldering pad
  pattern is optimized accordingly.

#### **Cleaning and Washing:**




