Description of Changes

TE was recently made aware that Dechlorane Plus, a chlorinated Flame Retardant, was added to the REACH SvHC candidate list by ECHA in January 2018. As a result, one of our PA66-GF0-V0 resins is no longer being produced. The part numbers listed are produced from this PA66 nylon. TE is taking swift actions to substitute this nylon with a new version with similar properties. All impacted part numbers are being superseded to new parts numbers using the replacement resin. We have evaluated our inventory position on this PA66 nylon and have estimated dates as to when we need to convert each part number. Our last ship dates noted within this PCN are an estimate as to when we will no longer be able to produce the impacted part numbers. We reserve the right to adjust this timing as needed based on material availability.

Reason for Changes:
