General Product Description:  
GET Female Terminal

Description of Changes  
TE Connectivity (TE) is implementing a running change to its GET female receptacle product, adding nickel under-plate and replacing silver plating in the crimp area with tin plating. This change has been tested to USCAR, meeting necessary performance requirements. End users of these terminals will not need to modify or change any current termination applicator equipment. TE does not foresee any process adjustments through the transition and implementation of this change. First planned deliveries are US-production-parts. Second stage (approx. 3 months later) then terminals produced in Europe will be delivered.

Reason for Changes:  
Product Improvement. TE is implementing this change on existing manufacturing plating processes using proven tin plating baths. Key benefits of this change will be to help eliminate silver plating build-up on termination applicators, as well as changing to a more preferred plating within the crimp area.
