




Total Power Dissipation vs. Ambient Temperature:


Absolute CTR vs. Ambient Temperature

Relative CTR vs. Forward Current (at V_{CF} =5 V)




Absolute CTR vs. Forward Current (at $V_{CE}=0,4$ V)


