

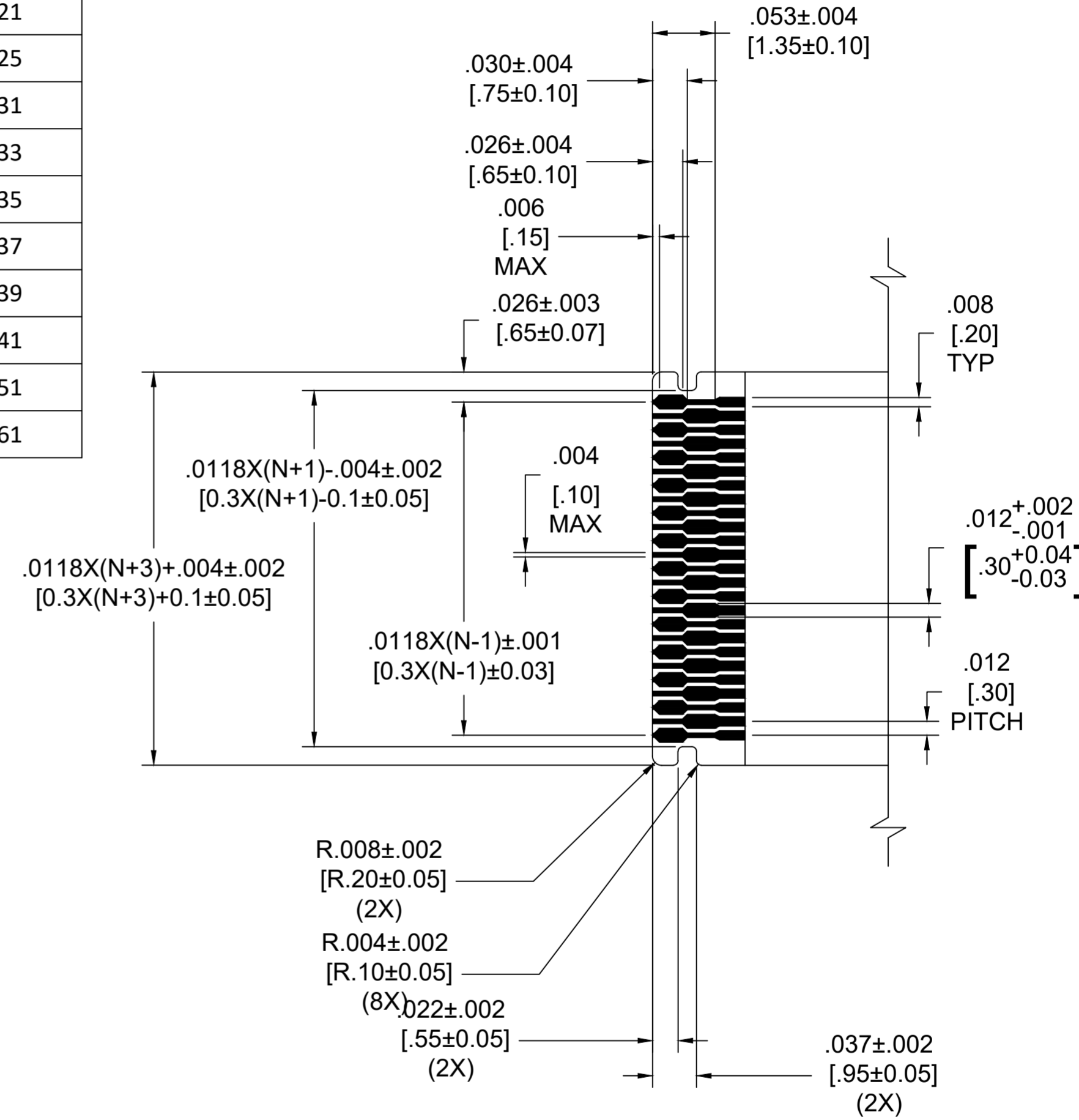
# 0.30MM CENTER FFC JUMPER CABLE CHART

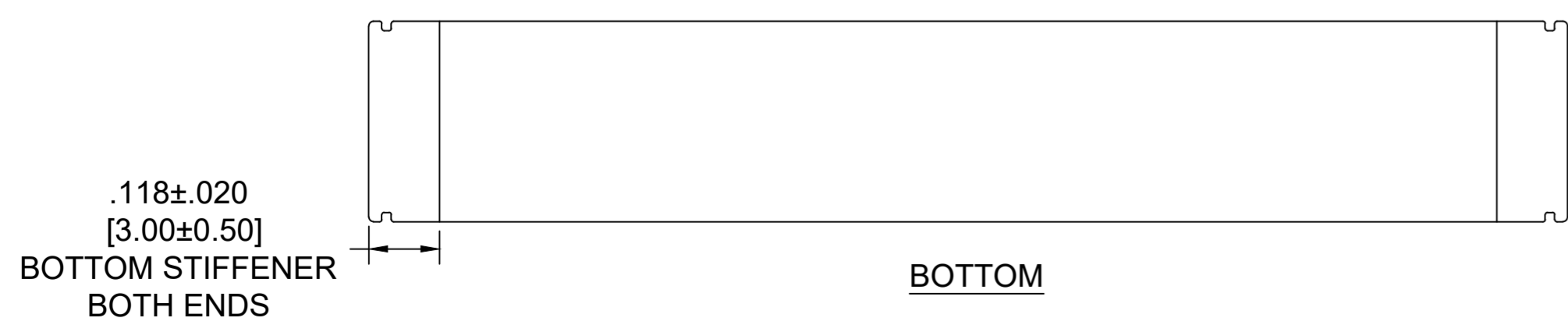
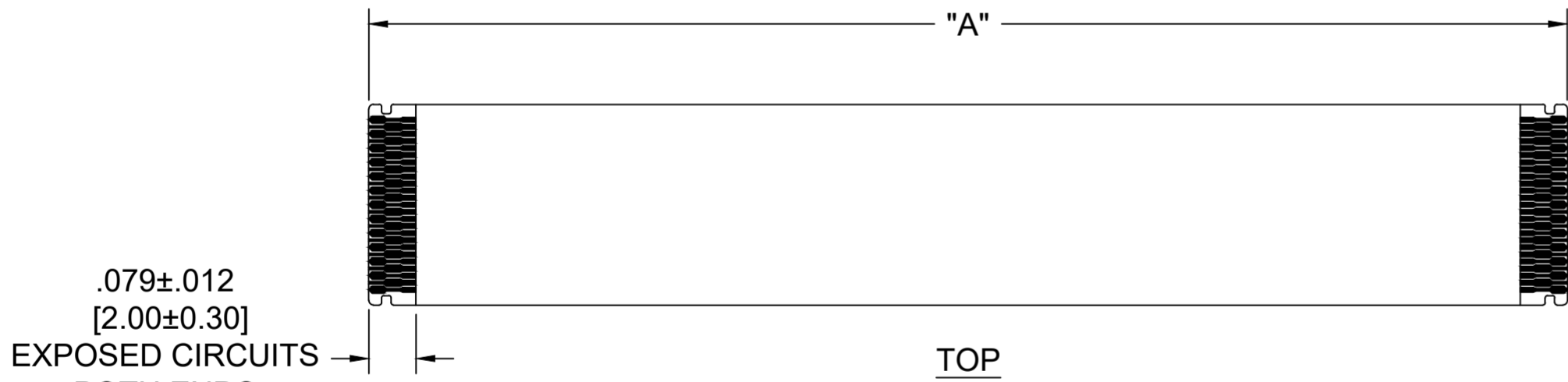
