DESCRIPTION AND PURPOSE:

ON Semiconductor has been informed by Plessey Semiconductors, our wafer foundry vendor for the listed product(s) in this notification, that they no longer offer wafer foundry services to ON Semiconductor or any other external customers.

The discontinued support is related to a change of focus of the business of Plessey Semiconductors, and is not an event within ON Semiconductor's control. Their business model is changing such that their full FAB capacity is needed to support internal Plessey Semiconductors Products. Despite several discussions between the management team of ON Semiconductor and Plessey Semiconductors this decision is final.
