This letter is to inform you that due to issues during the ejection of parts from the mold, the Industrial and Commercial Transportation business unit of ("TE") Connectivity is requesting your approval of a deviation that allows TE to manufacture the DTM Series 12 Pin -R019 and -R008 MOD part numbers (affected part numbers appear below) with pullers to avoid parts sticking and crashing the mold.

The need for this deviation is required now to maintain customer shipments and PCN-22-156615 is to be distributed prior to the end of the year for the addition of the puller.

NOTE: This is an appearance change only and does NOT affect fit or function.







